Jackson County, FL. – On March 11, 2025, at 9:00 AM, the Jackson County Board of County Commissioners held a Regular Meeting. This is a recap of some of the reports and requests included in that meeting.

## **RECOGNITION: Employee of the Month**

#### **REQUEST: Adoption of Corbin Rd FDOT Resolution and approval of the Agreement**

The Florida Department of Transportation (FDOT) has advanced funding for the design of CR 280 (Corbin Road) from US 231 to the Washington County line under the FDOT SCRAP program. The Board of County Commissioners approved the required resolution to enter into the grant agreement, allowing the County to move forward with survey, design, and permitting. This project will enhance roadway conditions by resurfacing and reconstructing travel lanes while adding 8-foot shoulders, improving both safety and accessibility for travelers.

## **REQUEST: Approval of Proposed Revision to Airport Zoning Ordinance**

The Board approved an update to the Airport Zoning Ordinance, enhancing regulations to support future growth and development around the Tri-County Airport. Since August 2024, County staff have worked closely with Avcon, Inc. to revise the ordinance, ensuring it aligns with modern aviation standards and land-use planning. The Planning Commission reviewed and recommended approval of the updates during its February 17, 2025, meeting, and the Board's approval marks a significant step in maintaining safe and effective airport operations for the region.



# <u>REQUEST: Approval of Work Authorization from DRMP for Survey and Design of Thompson</u> <u>Road Guardrail</u>

To ensure compliance with FDOT specifications for a clear zone behind the guardrail, the Board approved a Task Work Order with DRMP to evaluate the existing guardrail along Thompson Road from Bylsma Lane to Bart Road. This assessment will help determine the best approach for relocation while considering potential right-of-way impacts. As part of the project, the existing centerline, right-of-way, and boundary corners for two parcels will be established. This proactive step will enhance safety and improve roadway infrastructure for the community that utilizes Thompson Road.

## **REQUEST: Approval to Set Public Hearing for Source Global Phase III**

The Board has scheduled a public hearing for March 25, 2025, at 6:00 p.m. to consider the next phase of the Source Global Water Farm project. Recommended for approval by the Planning Commission on March 3, Phase III includes the construction of 1,447.2 square feet of hydro panels designed to capture water from the atmosphere. This project will support the Proud Source Water Bottling Plant by providing clean, sustainable drinking water. The project is located approximately .24 miles east of the intersection of Hwy 162 and Holyneck Road in unincorporated Jackson County.

## <u>REQUEST: Approval of TDC Sponsorship Reimbursement to Alabama High School Rodeo</u> <u>Association</u>

The Board of County Commissioners has approved a \$5,500 sponsorship reimbursement to the Alabama High School Rodeo Association for its January event, following the recommendation of the Tourist Development Council. Previously awarded \$6,000 in sponsorship funds, \$500 was allocated for event photography. With all required documentation in order, this reimbursement supports Jackson County's commitment to promoting tourism and hosting successful events that bring visitors to the area.

## **REQUEST:** Discussion of Debris Removal and Disposal Service Contracts

With existing debris removal contracts set to expire on May 15, 2025, the Board is taking proactive steps to ensure the County remains prepared for future storm recovery efforts. The Florida Division of Emergency Management (FDEM) has provided guidance on procurement and contracting, and by preparing new procurement documents before the 2025 hurricane season, the County aims to strengthen its eligibility for potential FEMA reimbursement. This effort reinforces Jackson County's commitment to effective disaster response and recovery.
